Pass in 8th Standard of a Recognized School.
4. **SENIOR GRADE TYPEWRITING (ENGLISH & TAMIL):**
Pass in the Junior Grade Typewriting Examination of the concerned subject or pass in SSLC or equivalent Examination of a Recognized School.
5. **SHORTHAND JUNIOR (ENGLISH & TAMIL) AND SHORTHAND ENGLISH INTERMEDIATE GRADE:**
Appeared SSLC or equivalent Examination through a Recognized School. Private Candidates must have passed SSLC or equivalent Examination.
6. **SHORTHAND SENIOR (ENGLISH & TAMIL):**
Pass in SSLC or equivalent Examination through a Recognized School (OR) Failed SSLC or equivalent Examination with a pass in Junior Grade Examination of the concerned subject.
7. **HIGH SPEED TEST IN TYPEWRITING AND SHORTHAND (ENGLISH & TAMIL):**
Pass in Senior Grade Examination of the concerned subject.
